Important Information

On Thursday, August 27, 2020 the Village Council voted on final disbursements of Indiantown Community Trust Fund (ICTF) Grants. Staff have finalized disbursement of ICTF funds according to Council direction. If you have questions or concerns, please contact Management Analyst Daniel Eick at deick@indiantownfl.gov.

Village staff are currently coordinating with the Indiantown Civic Club and the CDBG Mitigation program to explore converting the Indiantown Civic Center into a pet-friendly shelter. If successful, the DEO will provide funding for the project. Further information will be provided when available.

As of Monday, September 28, 2020 staff have moved into our new temporary Village Hall located at 15516 SW Osceola Street, Ste C, Indiantown, FL 34956. A press release was drafted clarifying information earlier this week and is attached in English and Spanish for review and distribution.

As of Tuesday, September 29, 2020 the Village of Indiantown Water & Wastewater Utility has finalized the purchase of the Indiantown Company Water and Wastewater Facilities. Power and Lights (FPL) regarding a petition filed with the State Department of Environmental Protection (DEP) to establish a site-specific alternative criterion (SSAC) for Total Ammonia Nitrogen (TAN). This project will affect cooling ponds in the Northwest Mitigation Area wetlands and Barley Barber Swamp in Martin County, Florida. As of Wednesday, September 30, 2020 Florida Governor Ron DeSantis authored Executive order 20-246, extending Executive Order 20-69, suspending any Florida statute requiring a quorum to be present in person and allowing local government bodies to utilize communications media technology to host public meetings. Emergency Management Matters

Starting October 5, 2020, Village staff are scheduled to return to full time operations. As such, Village Hall will be open to the public Monday-Thursday, from 8:00 a.m. to 6:00 p.m. Face masks and touchless thermometer checks will be required of all customers prior to entry. To maintain proper social distance, the front lobby will be limited to four (4) people at any one time. Customers attempting to access Village Hall with a temperature of 100.4 or greater will not be allowed to enter the lobby. Human Resources Updates

Human Resources continues work to transition Indiantown Water Co. employees to Village employees with HR onboarding currently underway. Water Company staff are officially Village employees as of October 1, 2020. Additionally, Human Resources has hired a second Utility Billing Clerk with a start date of October 13, 2020.

The Village Clerk's Office has posted a recruitment for the position of Village Financial Services Director. Currently, plans place the position to remain open until filled. However, it should be noted our first review of received applications is scheduled for October 13, 2020. 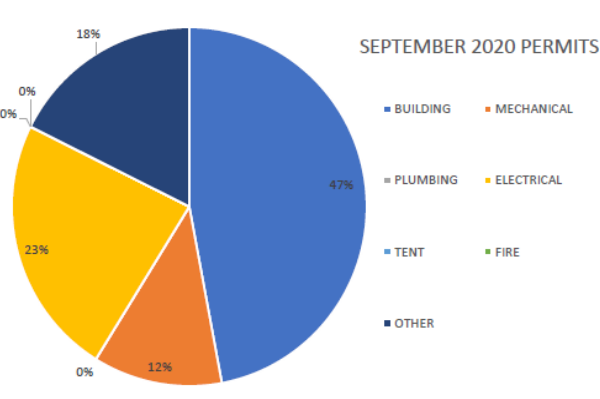

VILLAGE OF INDIANTOWN MOVES INTO NEW VILLAGE HALL

Relocated from shared Martin County Offices on Thursday, September 24

Indiantown, FL – The Village of Indiantown has moved into a new, more spacious Village Hall at 15516 SW Osceola Street. The move away from the shared Martin County Indiantown Branch Office, located at 16550 SW Warfield Boulevard, was completed this morning. The new office is being leased from Indiantown Non-Profit Housing Inc. and is located between SE Adams Avenue and SW Madison Avenue, one block south of the Indiantown Civic Center.

“The Village would like to collectively thank Martin County for providing us a space to evolve and grow over these past two years.” said Village Manager Howard W. Brown Jr. “In order to continue growing, and to provide the level of service our residents expect, we need additional space and are pleased to announce our new partnership.”

The new Village Hall has three suite entrances for Utilities, Administration and the new Village Council Chambers. The first suite will house the Utilities Department when the Village completes its takeover of the Indiantown Company Incorporated water and wastewater company. The center suite houses administrative offices, including the Village Council, Village Manager, Village Clerk, Planning, Community and Economic Development and Building & Permits Departments. The third entrance will lead to the new Village Council Chambers. The Parks & Recreation Department and Code Enforcement Offices will remain at Booker Park where they moved this summer.

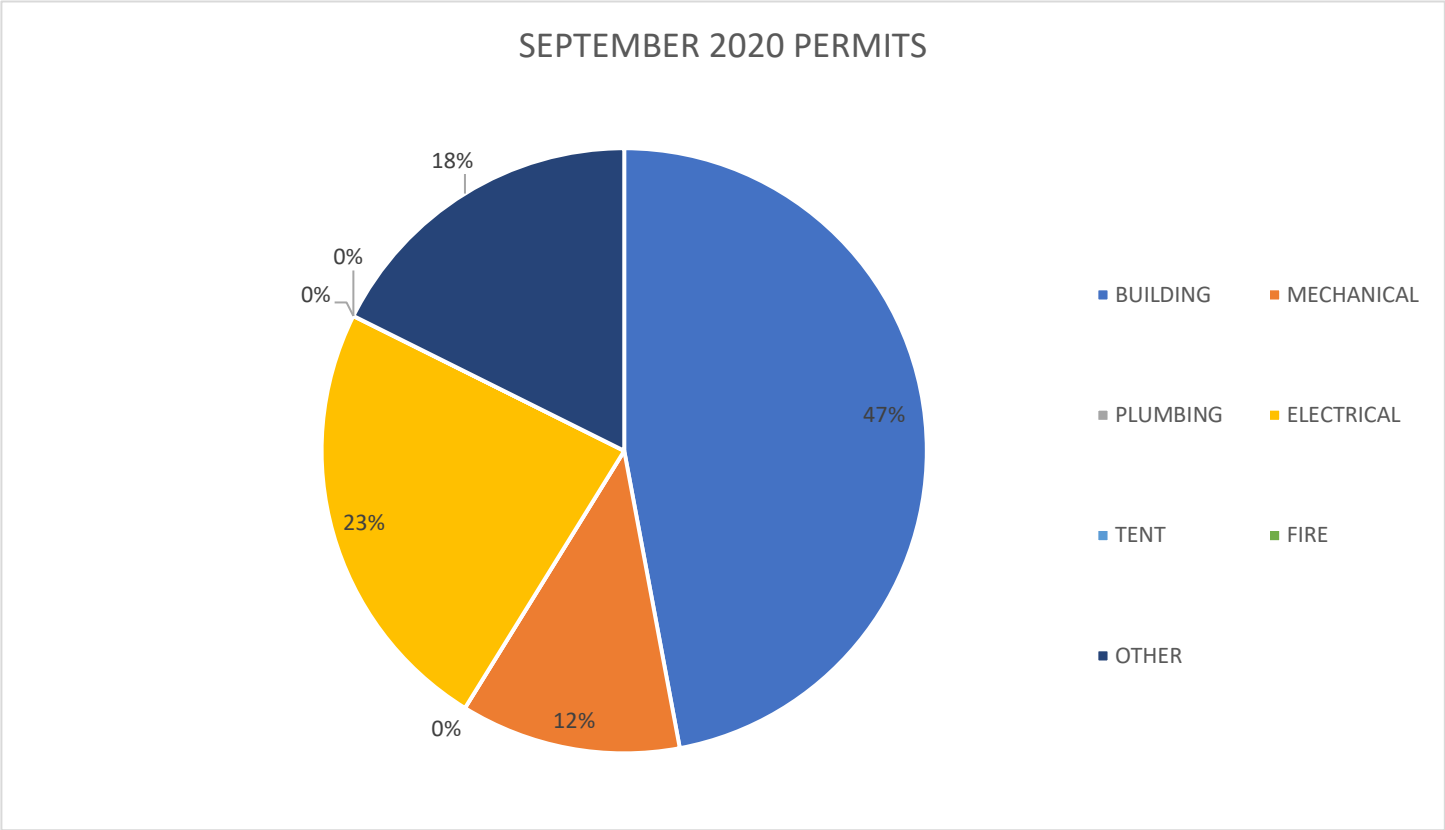

NORTH FLORIDA

Census is Granted in Jacksonville

The City of Jacksonville has been working with strategic partners to provide census outreach. One of these strategic partners is the Nonprofit Center of Northeast Florida. As a part of their efforts, The Center awarded more than \$40,000 in mini grants to programs doing direct community outreach to participate in the 2020 Census.

The Nonprofit Center's 2020 Census Mini-Grant Program is supported by The Lucy Gooding Charitable Foundation Trust and The Community Foundation for Northeast Florida, to identify, support and fund nonprofit organizations that are committed to ensuring a complete count of Northeast Florida residents during the 2020 Census with an emphasis on hard-to-count populations and census tracts.

Among those receiving grants:

- Elder Source developed "Operation Kindness" to provide local seniors with much-needed care packages of meals and essential supplies during the current pandemic. In addition to these essential items, Operation Kindness provided an opportunity to encourage seniors to complete the 2020 Census. Census reminders came in the form of stickers attached to the home-delivered meals as well as mailed postcards. This outreach effort spanned the 5 county Northeast Florida area.
- The Safe Future Foundation held a drive-through community baby shower for new and expectant mothers. Advertising for this event reached all of Duval county, with specific additional outreach to three zip codes in Jacksonville with low response rates to previous Census counts. The drive through baby shower provided important supplies such as diapers and formula as well as themed treats just like a traditional baby shower would have. Each participant was offered the opportunity to complete the census on a thoroughly sanitized tablet as their trunk was being loaded up with their baby shower gifts.
- The Sister Hermana Foundation held a "Count Me In" event at the International Brotherhood of Electrical Workers Local 177 Union Hall in Jacksonville's Eastside. With the help of volunteers from Bring It Home, DEM Kids Foundation, Northeast Florida Human Trafficking Coalition and Dr. Albert Chester, the event, attended by more than 300 people, provided the opportunity for participants to complete the 2020 Census on iPads and have lunch.
- First Coast Taekwondo promoted the completion of the Census among First Coast Taekwondo member families as well as the congregants of neighboring churches and residents of the Oak Hill neighborhood on Jacksonville's Westside. First Coast Taekwondo provided iPads to complete the 2020 Census in their lobby. As a result of their efforts, First Coast Taekwondo reports that more than 2,000 people engaged with their Census display.

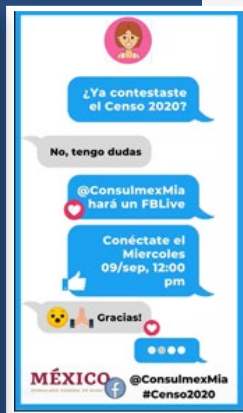

Mexican Consol, Others have Census Discussion

JJonathan Chait Auerbach, General Consul and President of Grupo Latinoamericano de Consules en Miami (GLACMI) hosted a Facebook Live virtual session of GLACMI and invited Census staff to address the consul generals of Argentina, Brazil, Chile, Colombia, El Salvador, Guatemala, Honduras, Mexico, Paraguay, Peru, Dominican Republic and Uruguay. Each one is engaged in supporting the 2020 Census and committed to work on the last push to ensure that their communities are counted. Mexico, El Salvador, Brazil, Honduras, and Guatemala agreed to host a weeklong MQA September 22 through 25.

Asian Community has Call to Action

The South Florida Asian community organizations came together to ensure that residents are counted in the 2020 Census. Key groups in South Florida leading the Census call to action include APIA Votes, AARP Asian, and Florida Asian Services. Throughout South Florida, more than 50 Asian partner organizations have worked stuffing 2020 Census bags with printed materials to deliver to local partners -- Asian restaurants and Oriental markets -- who will give them to their customers as a reminder to participate in the 2020 Census.

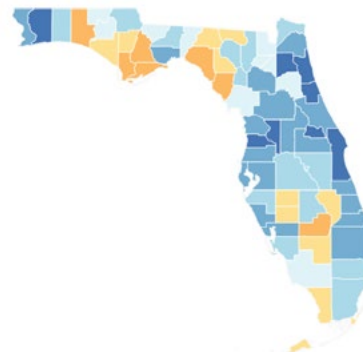
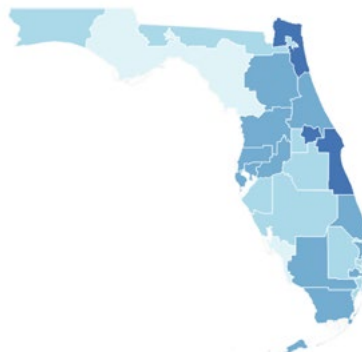

OFFICE OF THE GOVERNOR EXECUTIVE ORDER NUMBER 20-69

(Emergency Management – COVID-19 – Local Government Public Meetings)

WHEREAS, on March 1, 2020, I issued Executive Order 20-51 directing the Florida Department of Health to issue a Public Health Emergency as a result of COVID-19; and

WHEREAS, on March 1, 2020, the State Surgeon General and State Health Officer declared a Public Health Emergency exists in the State of Florida as a result of COVID-19; and

WHEREAS, on March 9, 2020, I issued Executive Order 20-52 declaring a state of emergency for the entire State of Florida as a result of COVID-19; and

WHEREAS, on March 16, 2020, President Donald J. Trump and the Centers for Disease Control and Prevention (“CDC”) issued the “15 Days to Slow the Spread” guidance advising individuals to adopt far-reaching social distancing measures, such as working from home and avoiding gatherings of more than 10 people; and

WHEREAS, on March 17, 2020, I wrote a letter to Attorney General Ashley Moody seeking an advisory opinion regarding concerns raised by local government bodies about their ability to hold meetings through teleconferencing and other technological means in order to protect the public and follow the CDC guidance regarding social distancing; and

WHEREAS, on March 19, 2020, Attorney General Ashley Moody delivered an opinion to me indicating that certain provisions of Florida law require a physical quorum be present for local government bodies to conduct official business, and that local government bodies may only conduct meetings by teleconferencing or other technological means if either a statute permits a quorum to be present by means other than in person, or that the in person requirement for constituting a quorum is lawfully suspended during the state of emergency; and

WHEREAS, it is necessary and appropriate to take action to ensure that COVID-19 remains controlled, and that residents and visitors in Florida remain safe and secure;

NOW, THEREFORE, I, RON DESANTIS, as Governor of Florida, by virtue of the authority vested in me by Article IV, Section (1)(a) of the Florida Constitution, Chapter 252, Florida Statutes, and all other applicable laws, promulgate the following Executive Order to take immediate effect:

Section 1. I hereby suspend any Florida Statute that requires a quorum to be present in person or requires a local government body to meet at a specific public place.


Section 2. Local government bodies may utilize communications media technology, such as telephonic and video conferencing, as provided in section 120.54(5)(b)2., Florida Statutes.

Section 3. This Executive Order does not waive any other requirement under the Florida Constitution and "Florida's Government in the Sunshine Laws," including Chapter 286, Florida Statutes.

Section 4. This Executive Order shall expire at the expiration of Executive Order 20-52, including any extension.



This order supersedes Section 4 of Executive Order 20-69.

Section 2. This order shall not apply to election canvassing boards.

Site-Specific Standard for Total Ammonia Nitrogen at the FPL Martin Next Generation Clean Energy Center

Florida Power & Light Company (FPL) has applied to the Florida Department of Environmental Protection (FDEP) for a site-specific standard for total ammonia nitrogen (TAN) applicable to water used for wetland hydration of the Barley Barber Swamp and the Northwest Mitigation Area. The hydration water is important to the restoration and preservation of the water cycle of these natural areas. The standard was established following U.S. Environmental Protection Agency (EPA) approved methodology, is protective of the resources, and will allow FPL to continue to hydrate the important natural areas surrounding the plant's cooling pond.

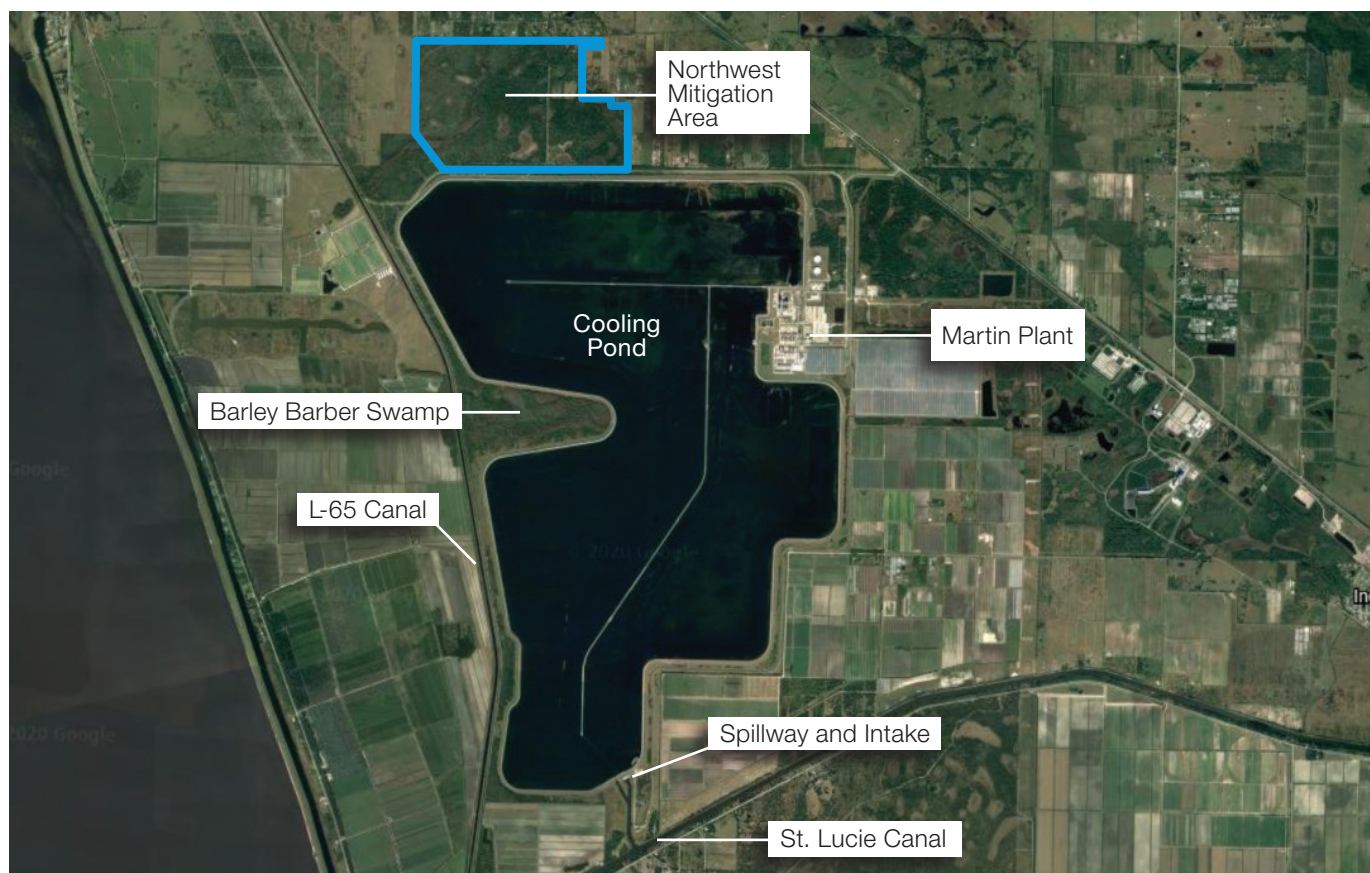


Cooling Pond Overview

The FPL Martin Next Generation Clean Energy Center operates a 6,800-acre cooling pond, which is a water reservoir. The cooling pond has a system that collects water that seeps through the cooling pond embankment. This water can be returned to the cooling pond or can be used to hydrate adjacent wetlands including the Barley Barber Swamp and Northwest Mitigation Area to aid in preserving the natural water cycle of these areas. Historically, the collection system has been used for wetland hydration

purposes; however, changes to Florida's water quality standards have limited use for hydration in the past several years.

The cooling pond is also authorized to discharge water via a spillway to the St. Lucie Canal during extreme storm events (emergency discharges) and gate tests; however, the cooling pond level is actively managed to prevent cooling pond discharges. In fact, there have been no discharges to the St. Lucie Canal in over five years.



Site-Specific Alternative Criterion Development

The cooling pond is regulated by an Industrial Wastewater Permit issued by FDEP. The permit sets specific water quality limits on water released from the cooling pond, including the water used for wetland hydration. In 2017, FDEP adopted a new water quality standard for TAN (Rule 62-302.530 of the Florida Administrative Code). The cooling pond seepage water is slightly above the new TAN standard; therefore, wetland hydration is currently limited. The TAN in the seepage water is slightly elevated because naturally occurring organic nitrogen is converted to ammonia through a biochemical process called ammonification as the cooling pond water seeps through the pond embankment. The EPA provides for a site-specific TAN standard if certain mussel species are absent from a waterbody.

To analyze site conditions and to continue hydrating the Barley Barber Swamp and Northwest Mitigation Area, FPL developed a mussel survey plan that was reviewed and approved by FDEP and EPA to identify whether a specific, highly sensitive, mussel species was present in these areas. A qualified consultant performed the survey and did not identify the mussel species. As a result, FPL applied to FDEP for a site-specific standard utilizing the EPA approved method. The requested standard is based on scientific data and utilizes the EPA approved methodology. It also provides a more accurate, yet protective, TAN criterion based upon the absence of mussels and will allow FPL to resume hydrating important wetland areas and continue to do so in the future. The site-specific standard must be approved by the FDEP and EPA prior to implementation and will only apply to water used to hydrate the Barley Barber Swamp and the Northwest Mitigation Area. FDEP's typical TAN criterion will continue to apply to water discharges, should they occur, from the cooling pond to the St. Lucie Canal.

KEY FACTS: Barley Barber Swamp

- » The Barley Barber Swamp is a 400-acre natural freshwater wetland that was set aside as a nature preserve when the plant was originally constructed in the late 1970s.
- » The Northwest Mitigation Area is a 1,200 acre mitigation area that includes both isolated herbaceous wetlands, forested cypress communities and uplands previously used for pastureland.
- » FPL has restored and enhanced the area by removing exotic vegetation and making hydrological improvements.
