


Important Information

Staff have been informed the Florida Public Service Commission recently approved Florida Power & Light (FPL) Company's new program to offer credits to qualifying small businesses impacted by coronavirus (COVID-19). The FPL Main Street Recovery Credit Program is the latest program initiated by the company to support adversely impacted customers during the global pandemic. The release provided to staff is attached to this document, or can be found by clicking on the icon to the left.



The Village Manager's Office has several important updates to deliver regarding ongoing Florida Department of Economic Opportunity (DEO) developments:

- Staff is coordinating with the Indiantown Civic Club and the CDBG Mitigation program to explore converting the Indiantown Civic Center into a pet-friendly shelter. If successful, the DEO will provide funding for the project. As of Friday, October 30, 2020 the DEO conducted a successful site visit. Further information will be provided when available.
- Additionally, staff is in the process of applying to the DEO's Rural Infrastructure Fund (RIF) grant program. The project in question will consider the feasibility of extending water and wastewater services out to the Martin County Fairgrounds via an engineering and design study. Further information will be provided when available.
- Finally, the DEO released information regarding their 2019 Annual Action Plan and Consolidated Annual Performance and Evaluation Report (CAPER). Alongside the draft document, the 2019 CAPER Public Hearing is scheduled for Tuesday, December 15, at 3:00 PM. Emergency Management Matters

Starting November 2, 2020, Village hall shifted to be open to the public Monday-Friday, from 8:00 a.m. to 5:00 p.m. Face masks and touchless thermometer checks are required of all customers prior to entry. To maintain proper social distance, the front lobby will be limited to four (4) people at any one time. Customers attempting to access Village Hall with a temperature of 100.4 or greater will not be allowed to enter the lobby. The Village Clerk's Office has received the Village's first CARES Act reimbursement check from Martin County totaling \$56,300. Following up on this, staff submitted a second final disbursement request. Further information on that request will be provided shortly.

The Clerk's Office has produced a conditional offer of employment for the position of Financial Services Director. Further information will be provided on this opportunity shortly.


As of Tuesday, November 17, the Village is in recruitment for a Grants Writer and Administrator. This position is scheduled to remain open until filled. Finally, the Clerk's Office is working to initiate a comprehensive pay/position compensation study. Further information will be provided during the Regular Council Meeting scheduled for Thursday, December 10, 6:30 PM.

Laserfiche (E-Records Management) Updates

The Clerk's Office is in the process of codifying the Village's Comprehensive Plan, Land Development Regulations, Property Maintenance Ordinance, and the Village's Charter. This process will pull all the relevant information into an easily accessible format for the convenience of the public, businesses and Staff.

Finally, Village staff have finished loading resolutions and ordinances onto our new document portal, Laserfiche. A link will be placed on the Village's website shortly where interested parties can search, view, print, and download official documentation. Additional documents, departments, and functionality is in development. Further information is forthcoming shortly alongside a scheduled press release.

The Finance Department has nothing major to report currently.

Parks & Recreation Department

Parks & recreation Department Staff is working alongside Martin County Mosquito Control to coordinate two (2) town clean up events focused on mitigating potential mosquito breeding grounds. The cleanup opportunities will be funded with grants provided by the Florida Department of Agriculture and Florida Department of Health. The events are scheduled for Saturday, December 5, at Post Family Park and Saturday, December 19, at Booker Park. Both events will be coordinated with help from Keep Martin Beautiful. A press release issued by the Village containing further information is attached to this document for review and distribution.

Public Works and Engineering Department

The Village's Public Works Director, William Archebelle, has several items to highlight. If you have questions, concerns, or wish to report a public works related issue, please contact publicworks@indiantownfl.gov.

- Staff continue to develop stormwater and drainage infrastructure plans throughout Booker Park consistent with grants provided alongside the Florida Department of Transportation (DOT). Project design and drawing is expected to reach 90% completion by end of December.
- Staff, PRP Construction, and Palmera Landscaping are working to perform swale cleanup, miscellaneous sidewalk repairs, debris removal, and ongoing cleanup throughout the Village.
- Ongoing emergency drainage repairs resulting from the inclement weather are expected to complete within the next two (2) weeks. Further information will be provided shortly.
- Finally, staff is working with Kimley Horn to address ongoing Infiltration and Inflow into the Village's Wastewater and Sewer system. Further information will be provided when available.

Water + Wastewater Utilities Department

Water + Wastewater Utilities staff is working on critical repairs and improvements throughout the Village, alongside the Code Compliance Division, designed to enhance water and wastewater flows, repair sewer lines, and clear rear alleys of debris and trash hindering operations. Further information will be provided when available.

Last week an incident occurred along Apopka Avenue that resulted in a fire hydrant being broken by a motor vehicle. As a result, the location of the fire hydrant was reassessed, and staff have relocated the device to an area further away from vehicle traffic.

Finally, staff is exploring possible improvements to stormwater systems throughout the Village to improve customer experience and limit damage caused by high infiltration events in the future. If you have questions or concerns, please contact jhewitt@indiantownfl.gov.




Riviera Beach capped off a Census Challenge that pitted the mayor, council members and residents to see which area could have the best response in the 2020 Census.


The challenge was just one of many of activities sponsored by the Riviera Beach Complete Count Committee. The City Council Census Challenge began August 6, 2020, when the 12 census tracts in Riviera Beach were divided among Mayor Ronnie Felder and the five council members: Tradrick McCoy, KaShamba Miller-Anderson, Shirley Lanier, Dr. Julia Botel, and Douglas Lawson.

The winner is the one that had the highest percent increase for their tracts. They received accolades as their reward and were announced at a recent council meeting.


The winner will be the one that has the highest percent increase for their tracts, and they will receive bragging rights as their reward. The winner will be announced at our next council meeting.

The results of the challenge is as follow:

- 1st Place – Councilperson Tradrick McCoy, District 1 (Census Tracts 10.04 & 13.01)
- 2nd Place – Mayor Ronnie Felder, (Census Tracts 10.03 & 13.02)
- 3rd Place – Councilperson Douglas Lawson, District 5 (Census Tracts 5.13 & 14.04)
- 4th Place – Councilperson Shirley Lanier, District 3 (Census Tracts 10.02 & 14.03)
- 5th Place – Councilperson Kashamba Miller-Anderson, District 2 (Census Tracts 12 & 15)
- 6th Place – Councilperson Dr. Julia Botel, District 4 (Census Tracts 5.09 & 5.12)

The city offered residents several ways to respond and ensure the elected officers receive proper credit, according to an e-blast from Riviera Beach:

1. District Census Challenge - City staff will collect census completion certificates from residents, but they MUST include the name of the councilperson they would want to give credit to. The councilperson that brings in the most certificates will WIN! Certificates can be submitted in three ways:

- * Submit a form online (a link will be provided shortly)
- * Mail a copy to: Attention, Marsha – Census, 1481 W. 15th Street Suite, 243, Riviera Beach, FL, 33404

2. Census Takers - City staff equipped with i-pads and laptops are conducting "Targeted Census Completion" in areas various communities and at mask distributions events.

3. Call Center - The city has three full time employees operating both an inbound/outbound call center trained to assist residents with completing their Census questionnaires. Their call center number specific for this purpose is 1-888-6-CENSUS (888-623-6787), open Mon-Friday, 9 a.m. to 5 p.m.

4. Trust Us Video - A video of trusted City employees encourages residents to either go online and complete the Census or call the City assistance line for help. This video airs frequently during the day before and after all scheduled meetings. The video has and will continue to be run on the city's social media platform to include all departmental social media pages.

In addition to the challenge, Riviera Beach CCC hosted multiple events and presentations to educate residents about the Census process. In May the CCC held a virtual concert and had several Mobile Questionnaire Assistance (MQA) events, where people could get help. City officials also sponsored a Census parade to capture residents' attention.

The U.S. Census Bureau Atlanta Region salutes the City of Riviera Beach for being a successful Partner in the 2020 Census.

Belle Glade Church Steps Up Several Notches for Census

The First Haitian Baptist Church of Belle Glade regularly ministers to its members. For the 2020 Census, this house of worship went to great lengths to alert the people in Palm Beach County about the importance of being counted.

Senior Pastor Morales St. Hilaire started the work for the census in 2019. He signed First Haitian Baptist as a partner, as he did in 2010. The church made numerous commitments: encourage congregants and community members to participate; display and distribute printed 2020 Census materials and advertisements; assist with recruiting and identifying job applicants, and provide speaking opportunities for Census staff and exhibit space. He also did presentations about the census.

Morana St. Hilaire, associate pastor and the social media director, said the COVID-19 pandemic caused him to take a different approach to reach members and others.

"Despite the effects of the pandemic, we were able to reach our people via different methods. We used social media to help us get the message out about the Census. Our social media campaign included sending messages to people via Facebook and Instagram," St. Hilaire said. "We used prerecorded video messages that were able to reach up to 100 to 200 people every day we had the message up. We also used other mediums such as WhatsApp, text messaging, and phone call outs."

St. Hilaire said that with WhatsApp the church sent out a video message every two days to reach about 50 to 60 of our congregants. "With this method our congregants are able to share the video with their friends and family. We saw a very high response as it relates to the Census turn out to our community."

To further their reach, church members did "mass callouts" and text messaging every week. "This method allowed for us to create a Creole version message and an English version message," St. Hilaire said. "We used this method for our video messages that we posted on the other media outlets."

St. Hilaire said the members noticed they were making an impact when people who did not even attend the church started sharing and commenting on their videos and messages. "We estimate that we were able to reach up to 45 percent of the Haitian population in the Belle Glade area," he said.

"With the innovative direction of our Census representative, we were able come up with these ideas. We are happy to report that many of the people that shared these videos also helped others fill out their census report."

Congratulations to the First Haitian Baptist Church of Belle Glade for being an outstanding Partner for the 2020 Census.

Steering Volusia County to Census Success

From Day One, the Volusia County Council members were on board with participating in the 2020 Census. In April 2019, the council agreed to form a Complete Count Committee (CCC). County Council Members Billie Wheeler and Barbara Girtman were named as CCC chairs.

The two co-chairs were highly visible and highly involved as the voices for Volusia's Census push. According to a March 10, 2020, article in the Daytona Beach News-Journal, "for seven months traveled from Pierson to Daytona Beach Shores making public appeals, all in an effort to boost the number of residents who fill out this decade's survey."

Those personal appeals – including news articles and opinion pieces -- were just part of the work of the Volusia County CCC. The committee includes all 16 municipalities, Volusia County Schools, universities, businesses, the faith-based community, migrant farmworkers, senior citizens, the United Way, and other social service agencies.

Pat Kuehn, Marketing Specialist for Volusia County, developed a marketing plan for the committee's 2020 Census outreach. The plan incorporated "eye-catching graphics for billboards, ads and social media." Kuehn said she communicated regularly with the Complete Count Committee members, which meant sharing graphics and census updates.


"I was impressed with our co-chairs, subcommittee chairs and city leads, who took this task to heart and reached out to their communities and clients. We had an incredible team!" Kuehn said. "Brian Rothwell, in particular, did an outstanding job of heading the Intergovernmental Subcommittee."

One effective collaboration, Kuehn said, was a "Run for the Roses" competition among Volusia's 16 municipalities. "Each week, I sent the latest self-response updates for the municipalities so they could see how they were doing. In the end, the City of DeBary took first place with 78.4 percent, and Ormond Beach and Deltona finished in a dead heat for second place," she said. On Nov. 10, the Volusia County Council presented a loving cup to DeBary officials to cap off the horse-race theme.

Kuehn said a campaign in 2030 would likely be very different in reaching residents. "It will be a new world. Newspapers will have continued their decline and movie theaters may be gone, so you'll have to focus on a multi-media approach. Also, you may want to allocate a good portion of your budget toward hiring part-time people who can hit the streets and talk to minority groups and college students," she said.


Her advice: Spend the latter part of 2029 "making your plans and developing your graphics, but don't launch your campaign until February 2030. Anything you do before then will be forgotten."

Fastest-Growing American Indian and Alaska Native (AIAN) Populations


By Percent Increase in Counties: 2010 to 2019

Indiantown's Thelma Waters Selected into Florida Women's Hall of Fame

Waters Recognized as a Pioneer of Civil Rights, Healthcare and Affordable Housing

Indiantown, FL – Florida Gov. Ron DeSantis announced the selection of Ethel Thelma Waters of Indiantown to the Florida Women's Hall of Fame. Each year, the governor selects three nominees from recommendations presented by the Florida Commission on the Status of Women (FCSW). The nominees exemplify the great diversity of women's contributions to Florida life.

"Thelma Waters has been a pillar of the community since her arrival many years ago," explained Indiantown Vice Mayor Jackie Clarke. "She always says a community is what people make it by working together and has proven that every day. We cannot thank her enough for her service to the community and are proud to support her in reaching this pinnacle."

Waters was a leading force in the local community for civil rights. In the late 1960s, she opened up her own daycare center to offer affordable childcare options to local farmworkers. She served as the director of the East Coast Migrant Head Start for 10 years, where she held monthly meetings for parents and taught English to help them understand what their children were learning. Waters advocated for healthcare in Indiantown so passionately, that the American Friends Service Committee assisted her in establishing a full clinic with its own doctors and dentists to serve the Indiantown community. Her next area of focus became establishing affordable and quality housing in Indiantown where in 1973 Waters helped facilitate the first neighborhood of affordably priced houses.

"The Florida Women's Hall of Fame was created in 1982 to honor women who, through their lives and efforts, made significant contributions to the improvement of life for women and all Florida citizens," said Commissioner Maruchi Azorin, Florida Women's Hall of Fame Chair. "They are pioneers who have broken down barriers, created new opportunities, and championed issues to better Florida and its people. Only three of these trailblazing women will join their sisters and be immortalized on an honorary wall in the halls of the Florida Capitol."

The 2020 Florida Women's Hall of Fame Induction Ceremony will be held on Thursday, January 28, 2021, at 5:30 p.m. The FCSW will provide additional information about the ceremony on its website at <http://fcsw.net/>.

FCSW is a non-partisan body with a focus on raising awareness and celebrating the contributions and successes of all Floridians, along with providing a collaborative platform for those seeking information on issues that affect women, girls and their families in our state.

Regulators approve FPL Main Street Recovery Credit Program to provide relief for small businesses in 2021

- *FPL continues to offer a range of relief options for all customers struggling with their electric bills due to COVID-19, including direct credits, payment extensions and waived fees for customers expressing hardship.*
- *Governmental assistance funding remains available for Floridians who need help paying their utility bills.*

JUNO BEACH, Fla. – The Florida Public Service Commission today approved Florida Power & Light Company's new program to offer credits to qualifying small businesses that have been impacted by the coronavirus (COVID-19) pandemic. The FPL Main Street Recovery Credit Program is the latest of several programs that the company initiated to show its steadfast support of adversely impacted customers during the global pandemic.

Establishments in FPL's service area that are eligible to apply for the program include:

- New small businesses
- Small businesses that were inactive for at least six months in 2020
- Existing small businesses operating in [federal Opportunity Zones](#) in FPL's service area

Qualifying small businesses would receive a monthly 10% credit on the energy charge portion of their electric bill for the duration of the program. The company will implement the FPL Main Street Recovery Credit Program for qualifying small businesses in January and offer bill credits through the end of 2021.

Recent studies showed the toll the pandemic has taken on the state's 2.7 million small businesses. Florida ranks fourth in the nation for business closures with 5,300 permanent closures and 3,300 temporary closures, according to a Yelp economic report. A recent survey of more than 4,800 Florida small businesses conducted by the Florida Chamber Foundation found that:

- More than half of businesses either voluntarily closed or were forced to close
- More than 30% suspended operations during the survey

- More than 45% expressed concern about their ability to operate in the future

"Despite COVID-19's unpredictability and disruptiveness, one thing remains clear – we are always committed to finding innovative ways to help our customers," said FPL President and CEO Eric Silagy. "We appreciate the Florida Public Service Commission's quick and thorough review and approval of this new initiative to help our small businesses and independent stores that make up the fabric of our communities. This program is one more way FPL is helping to rebuild our economy and move Florida forward."

Interested businesses can apply for the program on FPL's website, www.FPL.com, beginning next month.

Unwavering commitment to supporting customers

FPL's approved plan to assist small businesses is another example of direct relief that the company is providing customers in response to COVID-19, including those customers significantly behind on their bills.

Last month, FPL announced it donated \$15 million to help approximately 55,000 residential customers who receive federal assistance through the Low Income Home Energy Assistance Program (LIHEAP) or the Emergency Home Energy Assistance for the Elderly Program (E HEAP). These customers will receive credits on their monthly electric bill through December 2021.

In mid-March, FPL immediately began offering payment extensions and waiving late fees for customers experiencing hardship due to the pandemic, policies that remain in effect. During that time, the company also suspended disconnections for nonpayment and continued doing so for more than six months. Through a careful and measured approach, FPL resumed issuing final notices in September. To date, approximately 75% of customers who have received a final notice and passed their due date for payment have worked with FPL to make a payment arrangement and avoid disconnection for nonpayment. For those customers who were disconnected, more than 80% were reconnected within 24 hours following payment of their past due balance.

Since September, FPL issued more than \$15 million in bill credits to more than 112,000 residential and small business customers based on the status of their account and how long the account has been past due. Additionally, the FPSC unanimously approved FPL's plan to accelerate deposit refunds to eligible residential customers who have paid on time and in full for the last 12 months. The company is also planning to accelerate deposit refunds to eligible small business customers.

Indiantown Community Clean-up Events Focus on Mosquito Control

*Collaborative Efforts Made Possible by a Florida State Grant to Martin County Mosquito Control and
Volunteers from Keep Martin Beautiful*

Indiantown, FL – Two Indiantown community clean-ups will be held in December to control mosquito breeding. The clean-up events, made possible through a state grant to Martin County Mosquito Control, focus on cleaning up and collecting waste containers, tires, and litter along roadways within the surrounding neighborhoods. Volunteers for the events are coordinated by Keep Martin Beautiful.

“As Martin County Mosquito Control, we are excited to help a local community tidy up their neighborhoods, as well as focus on minimizing mosquito breeding habitats,” said Alex Majka, mosquito control resource specialist for Martin County.

The first event is scheduled for Saturday, December 5, from 8 a.m. to 11 a.m. at Post Family Park located at 15200 SW Adams Avenue, Indiantown. Interested parties can park their vehicles across the street at the Indiantown Civic Center and Indian River College lots. Volunteers will be supplied with rubber and leather gloves, buckets, pick sticks, garbage bags and safety vests. A dumpster will be located on the back side of Post Family Park along SW Osceola Street.

The second clean-up event will take place on Saturday, December 19, from 8 a.m. to 11 a.m. at the vacant property adjacent to the Booker Park sports field located at 15101 SW 169 Avenue. The vacant property is located at the corner of SW 169 Avenue and SW Charleston Street. Event volunteers can park and pick up supplies from the staging area near the fire station.

“We want to thank Keep Martin Beautiful for promoting the clean-up event and helping find volunteers to make this event possible,” said Albie Scoggins, parks supervisor for Village of Indiantown.

Martin County Mosquito Control will be utilizing grant funding in the amount of \$15,000, awarded through the Florida Department of Agriculture and Consumer Science and the Florida Department of Health, to provide personal protective equipment, personnel, waste removal, and the rental of utility vehicles for waste hauling. This grant is specific in that awarded funds must be used to conduct community clean-ups in areas with containers that promote mosquito breeding. To meet the grant requirements, two clean-up events will be held in the Village of Indiantown.

The Village of Indiantown will be providing a light snack for all staff and volunteers. Drinking water and community clean-up supplies will be provided by Martin County Mosquito Control.
