### **Rate Schedule**

The Village of Indiantown Water and Wastewater customer monthly rate schedule for FY 2021 is presented below:

<u>Water</u> - Effective upon Village Operations or 10/1/2020

1) Residential Services – Total Bill is the sum of the monthly base facility charge plus the gallonage charge per 1,000 gallons multiplied by the consumption or use in 1,000's of gallons.

#### 2) General Services – Non-Residential Customers

Meter Size Base Facility Charge Monthly is the same as residential Base Facility Charges shown in the Residential section.

Consumption Rate for each 1,000 gallons used in constant with use at \$2.46 per 1,000 gallons.

The monthly rate per 1,000 gallons of water metered is \$5.46 per 1,000 gallons.

3) Guaranteed Revenues

This rate is applied to a customer who has purchased capacity expressed in ERC's and the customers have not begun water use in an occupied building or endeavor. This rate offsets the fixed cost to maintain the purchased capacity for future use with no change in the Capital Capacity Fee (impact fee) paid into the future.

## Wastewater High Strength Surcharges

BOD (biochemical oxygen demand	\$ 49.02/100 lbs. (for amounts in excess of 500 mg/l)
SS (suspended solids)	\$ 42.98/100 lbs. (for amounts in excess of 700 mg/l)
Phosphorus	\$ 302.45/100 lbs. (for amounts in excess of 10 mg/l)
Nitrogen	\$ 453.89/100 lbs. (for amounts in excess of 40 mg/l)
