• Engineered wood fiber was delivered and installed at all three (3) playgrounds to bring the safety surfacing up to proper levels and improving the overall appearance of our parks. See attached photos.

- The tire drive held at Post Family Park on Saturday, April 23rd, was a great success! We were able to recycle 4,380 pounds of tires from the Indiantown area. It took two (2) full trailers to remove them. This will help reduce the mosquito population during the upcoming rainy season. See attached photo.
- Martin County Parks and the University of Florida Extension office will be hosting their 2022 Best Management Practices (BMP) training for Parks staff starting in May and the Village of Indiantown Parks staff have been invited to attend. See attached schedule.
- Parks and Rec Staff are working with other departments and respective event planner on the upcoming Da Swamp Event for June 24th - 26th. A meeting was held Monday, April 25th.

Public Works and Engineering Department

- Driveway specifications have been sent to the Building Department for residents to include with their applications.
- The erosion at Adams Ave bus stop has been repaired.
- The erosion under sidewalk on Jackson Ave has been repaired.
- PRP is fixing potholes.
- Trail Road Repair design proposal is forthcoming.

Water + Wastewater Utilities Department

- The replacement of the old water meters with radio read meters has commenced. This will be an ongoing project for several months.
- Staff are in the process of cleaning up around the Sewer Plant and Water Plant (i.e., Removal of surplus equipment & junk removal and lawn maintenance)
- Staff are continuing planning for the Water and Wastewater Plant upgrades with Kimley-Horn and Associates, Holtz Consulting Engineers, and CAPTEC Engineering.
- Staff are in the process of repairing all the automatic flushers throughout the water distribution system, which will improve water quality at the dead ends where they have been placed.
- Staff are on schedule with the new development that is coming to the Village. With Tractor Supply now being open and Indiantown Bio-Medical having started their site work, the utilities are the first items to be installed along with the storm drainage. Indiantown Bio-Medical is looping a water main to increase water pressure on a dead end main, which will increase fire flow for that area. Tractor Supply is also extending a water main; however, it will not have any effect until further growth extends it to the west. It will most likely be the Terra Lago Project that will pick it up.
- Staff are beginning to have planning conversations with the Terra Lago Developers and engineers, regarding the utilities.





B. Incident by Day of the Week


