Community and Economic Development Department

The Village's Community and Economic Development Director, Althea Jefferson, has several items to highlight.

Planning & Zoning

• The Planning, Zoning and Appeals Board is scheduled to conduct a Strategic Planning Session on November 17, 2022, at 6:30 pm.

Economic Development

 The Indiantown Rodeo will take place on October 14-15, 2022. The rodeo is sponsored by the Indiantown Chamber of Commerce. The Special Event Permit for the rodeo has been issued by Martin County due to the rodeo's location at Timer Powers Park, which is a Martin County facility in Indiantown.

Code Compliance

 The Code Compliance Division is scheduled to conduct a weekend community sweep in search of unpermitted and unlicensed business activity in the Village on Sunday, November 6, 2022.

Building Services

• The Building Division is reviewing plans for new residential buildings to be constructed in the Seminole Junction development. There will be five buildings containing a total of 28 townhomes. The 1.6-acre development is located at the intersection of SW Railroad Avenue and SW 170th Avenue in the Booker Park neighborhood.

Financial Services Department

The Village's Financial Services Director, Michael Florio, has several items to highlight.

- Staff is reviewing the application for Connecting Communities grant for mitigating and retrofitting transportation facilities. Possible projects include Warfield Blvd MLK/Booker Park revitalization and street conversions, as well as pedestrian walkways Village-wide. The application is due October 14, 2022.
- Mike Florio is working with consultants and staff to prioritize wastewater projects related to \$18M State Appropriation. The submission is due by the end of September.
- Daily financial operations for the Village:
 - The department is short-staffed in processing and posting of revenue and accounts payable
 - New third-party accounting and bookkeeping service is being obtained subsequent to approval by Village Manager / Village Council

Parks and Recreation Department

The Village's Parks and Recreation Director, Deborah Resos, has several items to highlight. If you have questions, concerns, or wish to report a Parks-related issue, please contact the Parks and Recreation Director at dresos@indiantownfl.gov or the Parks Assistant, Katina Joy, at kjoy@indiantownfl.gov.

- Parks staff is working with Minuto Locksmith to install one push release bar at the Parks office and Water treatment plant.
- Parks Staff met with contractors for pricing on improvements to Big Mound 2-story building in the back and replacement of the wooden deck at the front concession.
- Staff is working with PRP on replacing a sidewalk at Post Family Park to reconnect the playground and pavilion to make it ADA accessible. Work is scheduled for October 3rd.
- Parks staff has been working with vendors for quotes to replace ramps at the Post Family Skate Park.
- Parks staff met with One Call General Contractor for pricing for improvements to building security at Village Hall.
- Parks Staff met with Johnson Controls to improve security through badge access at Village Hall, the Water Plant and the Parks office.
- Parks Staff met with all Youth Sports Providers to get required documentation submitted for use of the Village athletic fields at no cost.
- Parks staff have been working with the Martin County Sheriff's Office to keep vagrants and visitors with alcohol out of our parks.
- Parks staff continue to provide administrative support to Finance, Public Works and Water Utilities.
- Park staff worked with Safety and Boot in Stuart to secure a contract to provide safety boots and PPE for all employees who work in the field.

- Parks staff attended Emergency Operations meeting to make sure the Village is in communication and attending all necessary trainings and updates.
- Parks staff is working with Martin County Records Department to share their public records training to be provided to all Village staff.

Public Works and Engineering Department

The Village's Interim Public Works Director, Patrick Nolan, has several items to highlight. If you have questions, concerns, or wish to report a Public Works-related issue, please contact publicworks@indiantownfl.gov.

- The Booker Park Drainage Project continues to move along and should be completed on time.
- Drainage work has been started and is in process by American Street behind Sandy Oaks.
- Planning for the Uptown Drainage project will be starting soon.
- Planning for the Trail Road project is in the Planning stage as well, we should have plans from Martin County to review by the middle of October.
- Installation of driveway aprons on vacant lots in Booker Park has commenced.

Water + Wastewater Utilities Department

The Village's Utilities Manager, Patrick Nolan, has several items to highlight. If you have questions, concerns, or wish to report a Utilities-related issue, please contact utilitybilling@indiantownfl.gov.

- We are in the process of cleaning up around the Sewer Plant and Water Plant (i.e., Removal of surplus equipment & junk removal and lawn maintenance)
- Continuing planning for the Water and Wastewater Plant upgrades with Kimley-Horn and Associates, Holtz Consulting Engineers, and CAPTEC Engineering.
- We are on schedule with the new development that is coming to the Village. The Tractor Supply is now open and the Indiantown Bio-Medical have started their site work the Utilities are the first items to be installed along with the Storm Drainage. The Bio-Medical has looped an 8" water main from SW Farm Rd. to Market St. Which will increase water pressure on a dead-end main and will increase fire flow for that area.
- Wrapping up the planning conversations with the Terra Lago Developers and engineers, regarding the Utilities.
- A blower unit at the WWTP has been replaced.
- Well pump #3 is in the process of being replaced due to a failure last week.
- A sewer force main has been repaired on Jefferson St.
- Two hydrants have been replaced in the distribution system, (1) Hitchcock's Market, (2) Martin County Fire Station.

A Place of Worship is a Permitted Use under the "Village Mixed Use" zoning classification for the property.




Overall, 260 incidents in August and September 2022. Incidents ranged from 0-10 a day, with the average being 4.3 per day.



B. Incident by Day of the Week


Takeaway: Overall, no significant pattern observed related to day of the week and count of incidents. No particular day stands out. No significant difference between weekends or weekdays.
