Gov. Ron DeSantis awards \$20 Million Dollars to the Village of Indiantown wastewater projects.

Indiantown, FL- On Friday, February 10, 2023, Governor Ron DeSantis signed Executive Order 23-06 that awarded the Village of Indiantown \$20 million dollars to support the wastewater infrastructure project. Executive Order 23-06 is part of the Governor's Framework for Freedom Budget for the 2023-2024 fiscal year.

The \$20 million dollars will be allocated to priority projects currently reflected in the village wastewater master plan. Indiantown acquired the utility, Indiantown Company Inc., and its facilities in 2020 and will continue to strive to make the necessary improvements to provide a safer, more reliable, and environmentally sound wastewater system for residents and businesses operating within the village.

The Department of Environmental Protection (DEP) Wastewater Grant Program helps fund wastewater infrastructure projects that build, improve, or expand wastewater treatment facilities to provide advanced waste treatment and projects to improve or convert traditional septic systems.

Water & Wastewater

- We are in the process of cleaning up around the Sewer Plant and Water Plant (i.e., Removal of surplus equipment & junk removal and lawn maintenance)
- Kimley-Horn has finished the Design for the Water Treatment Plan, and it is close to going to Bid.
- Holtz Engineering has begun the design process for the Wastewater Treatment Plant (WWTP).
- We have received the new Atlas Copco pump and put it into service at the front lift station at the WWTP due to pump failures.
- The new Jetter-Vac trailer has been used throughout the collection system, cleaning and removing debris.
- Next is the installation of water inflow protection covers throughout the collection system.
- The Operating Permit for the Wastewater Treatment Plant has been updated by Florida Department of Environmental Protection .



Public Works

- Planning for the Uptown Drainage Park will start soon
- The Booker Park Drainage Project continues to move along and should be completed on time.
- The Trail Road project is in the Planning stage, we have received plans from Martin County to review and have returned them with comments
- Met with CAPTEC Engineering to evaluate plans for the Seminole Drive Drainage project.
- Martin County has begun cleaning out ditches on Citrus, which will allow the Village to do the same on our portions of Citrus.

The Village of Indiantown Parks and Recreation Department is committed to providing the community with safe, quality parks for the residents to enjoy. The department is working to enhance programming and recreational activities focused on sports, exercise, family gatherings, concerts, volunteering, and fun-filled events for the community.



OBJECTIVES AND PLANS

- The Parks Department received approval from Village Council to complete a Parks Master Plan on February 23rd.
- Field improvements for Big Mound Parks are taking place.
 - Field D is currently closed and the field has been fertilized and fill has been added to improve the safety of the fields
 - Field E is scheduled to be closed in April and May. We need your help keeping groups off the field so the turf can grow.
- Parks staff is working with Kimley Horn on the landscaping Request for Proposal (RFP) and is expected to have it out for bid in the next couple of weeks.
- The three Little Libraries, in conjunction with the Palm City Chamber of Commerce, Project Lift, and the Boys & Girls Clubs of Martin County were installed last month.

Economic Development



Highlights

- On March 8, 2023, the Business Development Board of Martin County voted to include the widening of State Road 710 from Indiantown to Okeechobee in its 2023 Legislative Agenda for the Florida Legislature's current Legislative Session.
- A Special Events Application is being processed for a carnival on April 14-23, 2023, on Village-owned property at 15225 S.W. Warfield Blvd.
- A Special Events Application is being processed for the sixth annual DA Swamp Homecoming. This event is scheduled for Memorial Day weekend (May 26-29, 2023) at Booker Park.
- The Village Staff has approved a Certificate of Use Application for American Infrastructure Maintenance Management (AIMM) at 17301 S.W. Commerce Park Drive. The approval allows AIMM to have outdoor storage of vehicles and equipment. AIMM has a six-year contract with the Florida Department of Transportation (FDOT) to maintain area roadways under the jurisdiction of FDOT.
- Village Staff met with representatives of the Indiantown Rail and Commerce Center at 19100 S.W. Warfield Boulevard to develop a plan for assigning street names and addresses on the site to allow future industrial uses there.

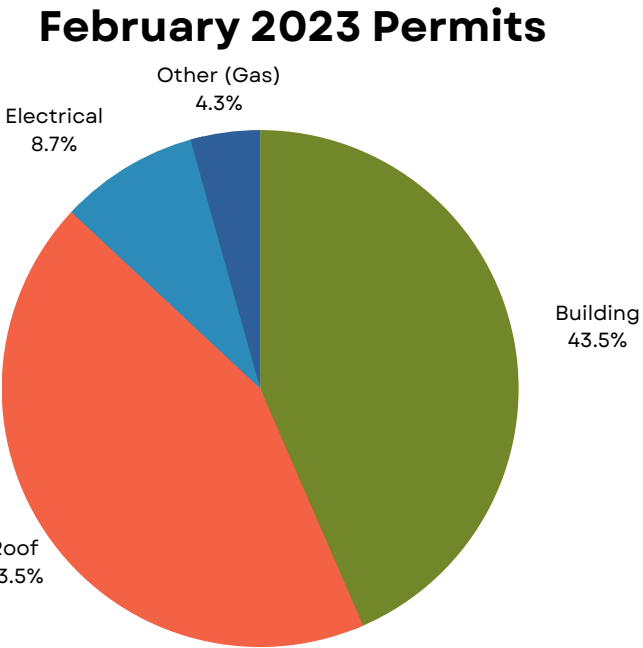
