Finance & Award Management




There are no new updates for the Finance Department. The following highlights below will be ongoing projects for the next few months.

A Brownsfield is a land area that has been impacted by environmental pollution in the past. This plan would be funded by a grant from the Treasure Coast Regional Planning Council in Stuart (TCRPC) A Community Workshop to discuss the proposed plan is scheduled for Thursday May 18, 2023, at 6:00 PM at Village Hall in Suite C.


