- Tyler Technology software implementation is forthcoming.



- Construction has begun on the new water main and wastewater force main for the IRSC Charter School
- Kimley-Horn has finished Design for the Water Treatment Plant, and it is out to Bid, a Pre-Bid meeting took place on Friday April 14, 2023 at the Water Plant on Farms Road where over 20 companies/organizations were present.

- On Wednesday, April 12th, Aries Industries stopped by the water plant to provide a demo of a crawl system camera. Aries Industries manufactures a Sewer Line Inspection Camera. This camera is used to identify sources of infiltration and to locate infrastructure. These features alone will cut costs in labor and contracted services while providing some same day services in most cases.



Public Works

No new updates, these projects are still in the works.

- Planning for the Uptown Drainage Park will start soon
- The Booker Park Drainage Project continues to move along and should be completed on time.
- The Trail Road project is in the Planning stage, we have received plans from Martin County to review and have returned them with comments
- Met with CAPTEC Engineering to evaluate plans for the Seminole Drive Drainage project.
- Martin County has begun cleaning out ditches on Citrus, which will allow the Village to do the same on our portions of Citrus.

Economic Development



Highlights

- The Village Staff coordinated with the Treasure Coast Regional Planning Council and its consultant, Stantec, to consider the preparation of a Brownsfield Redevelopment Plan for an area of the Village that may have been impacted by environmental pollution in the past. This plan would be funded by a \$500,000 grant that the Regional Planning Council received from the United States Environmental Protection Agency.
- The Treasure Coast Regional Planning Council (TCRPC) has completed a “Comprehensive Economic Development Strategy 2022-2027” for the four-county region that includes Palm Beach, Martin, St. Lucie, and Indian River counties. A copy of the report may be obtained from the TCRPC website at tcrpc.org.
- The Business Development Board of Martin County has prepared an article regarding the recent Village approval of development plans for Grind Hard Ammo, LLC. A copy of the article, which was published in the Stuart News on March 13, 2023, is attached.






Overall, 260 incidents in February to March. Incidents ranged from 0-10 a day, with the average being 4.4 per day.



B. Incident by Day of the Week


Takeaway: Overall, there was a significant pattern observed for the month of February between Sunday through Thursday.
